Youth riders (thru age 21) are not limited to 3 caps per season. Please pay capping fees to the Field Secretary, prior to mounting.

Subscriptions may be paid in equal quarterly or monthly installments.

Patron and capping fees may be applied to same-season subscription fees.

## WAIVER OF LIABILITY BASED ON EQUINE ACTIVITY

I, \_\_\_\_\_, acknowledge that, as an equine activity participant, pursuant to ORC 2305.321, by fox hunting with Miami Valley Hounds, Inc. (dba Miami Valley Hunt) and/or participating in other mounted activities sponsored by the Miami Valley Hunt; including but not limited to, trail rides, hunt derby, clinics, joint meets with other hunts. as an equine activity participant for 2022-2023, commencing on the first day of July 2022 and continuing through the thirtieth day of June 2023.

As an equine activity participant I am subject to the inherent risk of an equine activity, meaning a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following:

- (A) the propensity of an equine to behave in ways that may result in injury, death, or loss to persons in or around the equine;
- (B) the unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- (C) hazards, including, but not limited to, surface or subsurface conditions;
- (D) a collision with another equine, another animal, a person, or an object;
- (E) the potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

By signing this written waiver, I acknowledge that the equine participant who is the subject of this waiver, as well as the parent, guardian, custodian, or other legal representative of the equine activity participant who is the subject of the waiver, does not have a claim or cause of action upon which a recovery of damages may be based against, and may not recover damages in tort or other civil action against, any and all equine activity sponsors, another equine activity participant, equine professionals, veterinarians, farriers, or other persons associated with this activity, including, but not limited to, the Miami Valley Hunt, its Masters, officers, directors, trustees, members, subscribers, patrons, employees, guests and/or the landowners upon whose land we host activities.
